POS 53 for FUH Community Mental Health Centers

To accurately record and account for FUH visits for Community Mental Health Centers, POS 53 can be used. These services will count for FUH for all providers of service on-site providing face-to-face visits, who are able to use the CPT codes.

Follow-Up After Hospitalization for Mental Illness (FUH)

Description:

The percentage of discharges for members 6 years of age and older who were hospitalized for treatment of selected mental illness diagnoses and who had an outpatient visit, an intensive outpatient encounter or partial hospitalization with a mental health practitioner. Two rates are reported:

- Follow-up within 7 days of discharge
- Follow-up within 30 days of discharge

Tips for Success:

This measure focuses on follow-up treatment, which must be with a behavioral health practitioner.

- When using POS 53 at a CMHC, any provider who can bill the CPT/HCPC codes listed below will count for FUH.
- When one of your clients is discharged from an inpatient mental health stay, please make every effort to provide a follow-up appointment within 7 days.
- If a situation arises where a client is unable to be seen within 7 days, ensure they have an appointment within 30 days of discharge.
- Virtual visits (POS 02) are an effective way to provide care within 7 days after discharge but must be completed by a licensed behavioral health provider to count for FUH.
