# Prior authorization is required for:

- Inpatient behavioral health services
- Partial hospitalization
- Non-hospital medical detoxification
- Medically supervised or alcohol drug abuse treatment center (ADATC) detoxification crisis stabilization
- Early Periodic Screening Diagnosis, and Treatment (EPSDT) services
- Research-based behavioral health therapy (RB-BHT)
- Peer Support (As of Jan. 1, 2024)
- Substance abuse Intensive outpatient (SAIOP)- after initial 30 calendar days of treatment
- Substance abuse comprehensive outpatient treatment (SACOT) after initial 60 days
