

# **New Hampshire: Billing for Behavioral Health Integration Services**

The New Hampshire Insurance Department issued <u>billing code and coordination of care guidance</u> for payers, contracted behavioral health providers and interested associations. The goal? Support Behavioral Health Integration Services within primary care settings to help provide earlier access to mental health services, enhance collaborative care and improve patient outcomes – while reducing claim denials.

This guide aims to help clarify common billing questions to reduce denials on Behavioral Health Integration claims for fully insured commercial plan members ages 21 and younger.

#### Differences in care



#### **Behavioral Health Integration care**

- Starts with and is led by teams in the behavioral care setting
- Integrates mental health into primary care or other medical settings
- Focuses on non-preventative behavioral health issues and systematic care management
- Is billed under the patient's behavioral health benefits

#### **Psychiatric Collaborative Care**

- Starts in and is led by teams in the primary care setting
- Primary care teams manage a variety of medical care and consult with behavioral health providers as needed
- Is billed under the patient's medical benefits

## **Billing guidance**



#### Rillable services

The following codes are Behavioral Health Integration codes that are contracted and reimbursed by Optum Behavioral Health.

The following are medical Psychiatric Collaboration of Care billing codes. They are not contracted or reimbursed by Optum Behavioral Health.

#### Other billing notes

Behavioral Health Integration Services delivered by a behavioral health provider should follow Optum's reimbursement policy and/or their contract

## Key definitions and requirements



#### "Incident to" services

Behavioral Health Integration Services are considered "incident to" services when they are delivered by other members of the behavioral health care team under the direction of the billing provider.

- Care team members are either employed by or contracted by the billing provider
- These services are subject to state laws/licenses that apply to their practice specialty



## General supervision for services delivered by non-treating provider

General supervision:

- Is defined as Behavioral Health Integration Services not personally delivered by or under the overall direction and control of the billing provider and that do not require their physical presence
- Is listed in the Medicare Physician Fee Schedule (MPFS)
- Alone, does not create a qualifying relationship between the billing provider and other care team members
